## 2. Approval of Minutes

#### 5. Consider Approval of Expenditures for Emergency 9-1-1 Network

Van Bush, Regional 9-1-1 Network Director gave an overview of the expenditures. ESRI subscription renewal for 9-1-1 Addressing in the amount of \$158,881.82, the replacement of GIS servers in the DETCOG and county offices. Because the exact cost of the GIS Servers will not be known until the order is placed, Van Bush and Lonnie Hunt made a recommendation to approve in an amount not to exceed \$155,000, and the 4-year extension of 9-1-1 CPE hardware maintenance and monitoring agreement with AT&T Public Safety, authorized agent for Motorola Solutions in the amount of \$137,215.70. Guessipina Bonner made a motion to approve all expenditures for the Emergency 9-1-1 Network, seconded by Robert Shankle. Motion passed with no opposition.

- 6. Approval of Donation of Plotter being Replaced per 9-1-1 Program's Equipment Replacement Van Bush explained the printer is due to be replaced and the math department at Lufkin High School will utilize it for the benefit of their students. Leroy Hughes made a motion to approve the donation of the plotter to Lufkin High School Math Department, seconded by Roy Boldon and Musetta Hosey. Motion passed without opposition.
